- **Brief Report of 'Orientation on Chartered Accountant and Company Secretaries' for First Year B.Com Students by Department of Commerce at M.E. S College of Arts & Commerce, Zuarinagar-Goa**

Department of Commerce organised an Orientation programme on Chartered Accountancy and Company Secretaries for B.Com Semester- I students from all divisions on 13th August 2022. The orientation programme was attended by **81 students** and **seven faculties** from Department of Commerce. The resource person for the programme was C.A. Elson Sequeira from the Institute of Chartered Accountants of India and Advocate S. Rama Rao from the Institute of Company Secretaries of India. Principal, Dr Manasvi M. Kamat delivered a welcome addressed and highlighted the importance of Chartered Accountancy course and Company Secretaries courses in nation building on a large scale.

Principal, Dr. Manasvi M. Kamat advised the students to take up these professional courses as it will give them higher status and position in the society. She explained the objective and outcome of the orientation.

Dr. Sancheliana Faria, Head Department of Commerce introduced the resource person C.A. Elson Sequeira and Advocate S. Rama Rao to the gathering. Resource person C.A. Mr. Elson Sequeira from the Institute of Chartered Accountants of India not only explained the wide area of field under which C.A. works but also gave detail information on registration procedure and step wise process of completing CA final course. He advised students that they can pursue the course with 12th Std and also after graduation. He explained the different pattern of Chartered Accountancy Examination. He said that the role and experience of C.A's is utilized as much as possible, starting from Auditing, tax planning, capital planning, budget planning, preparation of laws and regulations to the implementation of Goods and Service Tax (GST). He advised the students to work very hard and try to be best in the respective profession as success and money automatically will follow.

Resource person, Advocate S. Rama Rao from the Institute of Company Secretaries of India highlighted the significance of Company Secretaries course and wide area of Career options available after Qualifying Company Secretary(CS). He also elaborated on various job opportunities available to a qualified Company Secretary. He said that a qualified company secretary is capable of finding a job in the public and private sectors, financial institutions and banks. He also suggested that Company Secretaries are also required in company law boards, various government departments, Department of Company Affairs, and other organisations. Advocate S. Rama Rao advised students to study smart rather than to study hard, while guiding on different aspect of Company Secretaries examination.

The orientation session was compered by Mr. Vedant Dabolkar from B.Com semester V div A. Asst. Prof. Dr. Atmaram M. Tarpe, Event coordinator for Orientation on Chartered Accountant and Company Secretaries proposed the vote of thanks.
