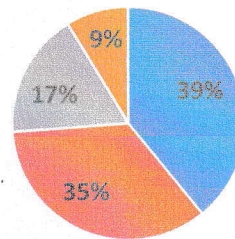

Analysis of the feedback highlighted the following points.

- The faculty had a positive opinion of the course objectives as 61% strongly agreed that there was clarity in the objectives that were reflected in the syllabus while
- The teaching staff were of the opinion (57%) that the Course is well organized in terms of teaching hours prescribed and the flow of the content.
- The staff members (65%) were also highly appreciative of the fact that the Course laid emphasis on fundamentals, coverage of modern/advanced topics, and maintained a good balance between theory and application.
- Majority of the faculty (52%) stated that the Course was well-structured to achieve the learning outcomes.
- The teaching staff (57%) showed a strong opinion that the books/reference materials prescribed are relevant, updated and appropriate.
- Many teachers (52%) were also of the opinion that the course/syllabus has enabled teachers to update knowledge and understanding in the subject area.
- Most faculty members agreed that the course / programme offers sufficient number of optional papers.
- Some of the suggestions given by them include; there is scope for improving the course content, introducing practical component for papers only offering theory, introduction of internship program as a compulsory component for subjects offering honours, and incorporating more optional papers for students.
